# INTRODUCTION SUMMARY

Gross earnings for the month ending December 31, 2022 were 2.148%. Gross earnings for the quarter ending December 2022 was 1.861%. Current average maturity of the portfolio 1.41 years with an average duration of 1.31 years. The current Par Value of the pool is \$7.642 Billion. The largest non-government aggregate position is currently Credit Agricole and Royal Bank of Canada at 1.10%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2022-23 is 1.85%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

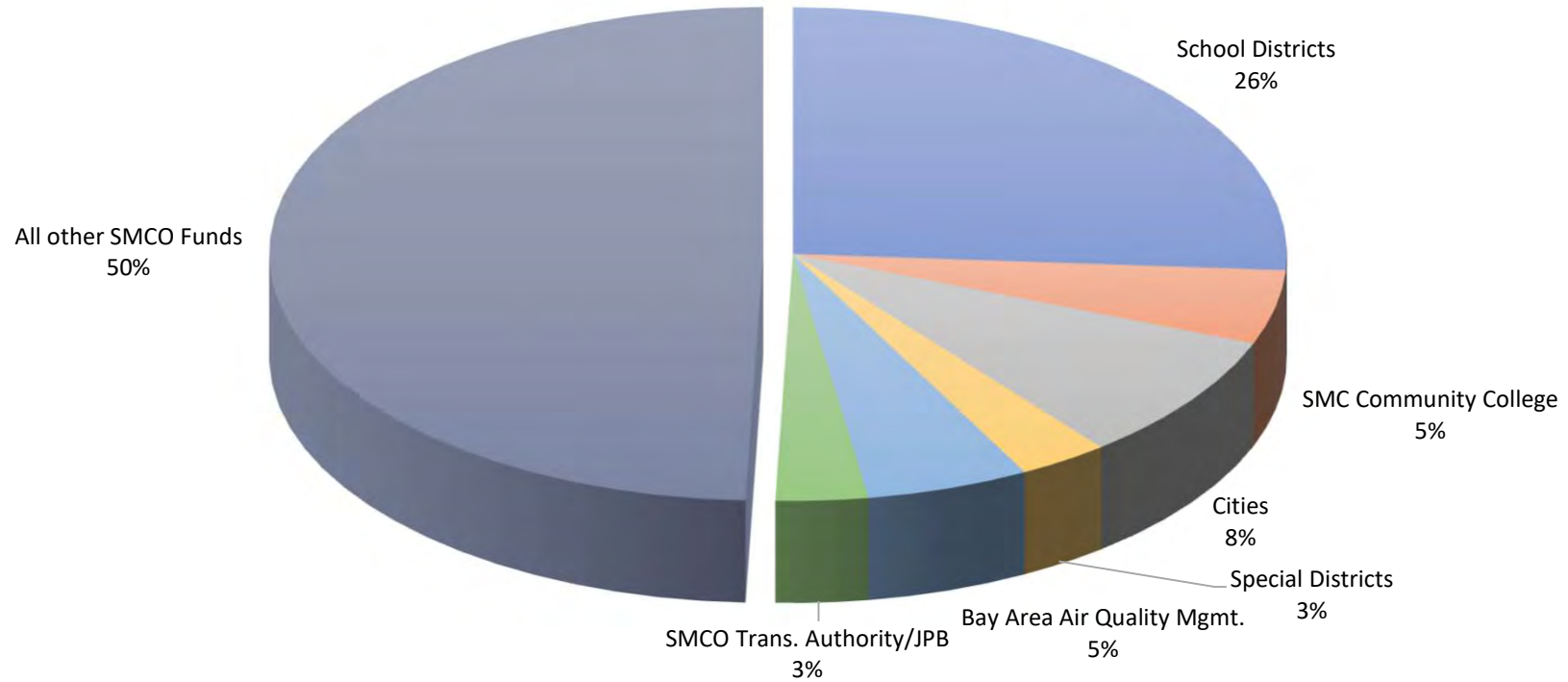
